Project: CIT industrial Equipment

To provide/deliver Industrial Equipment to CIT of Technological University of the Philippines, Manila Campus

1. The Technological University of the Philippines, through the General Appropriation Act and/or Continuing appropriation intends to apply the sum of Four Million (ph. 4,000,000) being the Approved Budget for the Contract (ABC) to payments under the contract for **Industrial Equipment**. Bids received in excess of the ABC shall be automatically rejected at Bid opening.
2. The Technological University of the Philippines now invites Bids from eligible Bidders for **Industrial Equipment**. Delivery of the **Industrial Equipment** is required by One Day upon receipt of Notice to commence. The description of an eligible Bidder is contained in Section II of the Bidding Documents, ITB.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act," and is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138). Only Bids from Bidders who pass the eligibility check will be opened. The process for the eligibility check is described in Section II of the Bidding Documents, ITB. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine responsiveness of the bid to technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during the post-qualification procedure.
4. Interested Bidders may obtain further information from BAC Secretariat at Administrative office with Tel. 3027750 at Ayala Blvd. Ermita Manila and inspect the Bidding Documents on January 25, 2007 at the address given above from 8:00 am to 5:00pm.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address above and upon payment of a nonrefundable fee in the amount of Four **Thousand Pesos (ph. 4,000)**. The method of payment will be CASH. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative.
6. The BAC of Technological University of the Philippines will hold a Pre-Bid Conference open to all interested parties on February 6, 2007 at 1:30 pm at 1st flr. AVR Bldg. Ayala Blvd. Ermita Manila.
7. Bids documents and eligibility requirements must be delivered to the address above on or before February 20, 2007 at 1:30pm at the 1st flr. AVR Bldg. Ayala Blvd. Ermita Manila. All Bids must be accompanied by a Bid security in the form of CASH and in the amount of ONE percent (1%) of the total Approved Budget or an equivalent amount in a freely convertible currency. Late Bids shall not be accepted.
8. Bid opening shall be on February 20, 2007 at 2:00 pm at 1st flr. AVR bldg. Ayala Blvd. Ermita Manila. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below.
9. The Technological University of the Philippines reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
